

## GENERAL INFORMATION & SPECIFICATIONS



### General Warranty Policy

All products shown in our catalogs are covered by a one year warranty against defective material or workmanship from date of shipment.

Any such product found to be defective as a result of faulty manufacturing will be replaced in whole or parts thereof, but no labor costs or other consequential damages shall be allowed.

This warranty is in lieu of all other warranties expressed or implied.

The manufacturer shall not be liable for any delay or failure in delivery or shipment of products, or for any damages suffered by reason of such delay or failure when such delay or failure is directly or indirectly due to fire, flood, war, riots, accidents, embargoes, labor stoppages, inadequate transportation facilities, shortages of materials or supplies regulated by government authority, or inability to obtain suitable or sufficient labor or raw materials.

All shipments are F.O.B. Jasper, Indiana. The responsibility of the manufacturer ceases upon delivery of goods in good condition to transportation companies and all goods are shipped at consignee's risk.

Merchandise is not to be returned to the manufacturer without proper written authorization from the factory.

### Decora<sup>®</sup> Dovetailed Drawer Box Lifetime Limited Warranty

Aristokraft, Inc., warrants its Decora<sup>®</sup> dovetailed drawer box against defects in material and workmanship for as long as the original residential purchaser owns the product.

Aristokraft, Inc., will send the original residential purchaser a new Decora<sup>®</sup> dovetailed drawer box to replace any defective dovetailed drawer subject to this warranty. This is a warranty for replacement only. Aristokraft, Inc., specifically does not cover drawers which have been exposed to abuse, misuse, or excessive loads.

To obtain replacement, remove the defective drawer from the cabinet and remove the drawer front and hardware from the drawer box. Mail the drawer box and \$7.00 (certified check or money order) for postage and handling to:

Please enclose a letter explaining the defect with a copy of your proof of purchase. Give the full name and address of your dealer and original installer. Allow approximately four (4) weeks for replacement.
